

CONTRACT RATIFIED

For the first time in decades, Local 598/GM workers turned down the tentative National Agreement presented by the National Bargaining Team in a close vote of 51.8 % to 48.2%. Interest in the agreement was also at an all-time high; 3,425 workers cast their votes – an excellent turnout from our membership.

Tensions and opinions ran strong and the information on the details of the agreement were rolled out to members at Whiting Auditorium where questions were answered by Chairman Eric Welter and other members of the bargaining team who were present. The "White Book" and other documents were available, along with the highlights, for all to read and discuss. There were many passionate discussions.

On November 20th, after all 50 bargaining units had weighed in, the contract passed 54.74% to 45.26%. The new contract will run through April 30, 2028.

Thank you to the National Bargaining team for all their hard work, including Bargaining Chair for the LOC Subsystems, Takeisha Hillard, who was on the negotiating team for her unit. Each of them spent countless hours away from families and their elected jobs. They fought for and brought home a very rich agreement. UAW members will receive more in general wage increases than they have in the past 21 years combined. Job security in the form of an investment of \$851 million in our plant guaranteeing us the next generation ICE truck. Healthcare improvements at no monthly cost to our members. COLA is restored. Retirees (and surviving spouses) will receive a \$500 yearly bonus for the life of this agreement beginning in the December pension check. These are just a few of the improvements that we are receiving. This contract will be life changing for many people.






This has not been an easy task for any of us, because the contract affected a lot of us differently.




However, at the end of the day, we all belong to the same Union.






It has always been my belief that all children deserve that Christmas magic, at least once in their lives.



Tools From The Past Used Today

In November of 1965, Local 598 would go out on a 30-day strike that would result in "The Comparison Agreement" being established.

by Michelle Giorgis – Education Committee This agreement was a scientific method used to establish job standards, creating a level of reassurance to the membership that it would make it more difficult for management to manipulate or overload the jobs. It would also reassure the members that even though the jobs could change throughout the years there was a formula that would now prevent the jobs from being overloaded.

For many years prior to this agreement, jobs were dangerous, overloaded, and operators barely had time to finish the jobs before they were running to the next job attempting to keep up. This was a great point of tension between the Union and management, creating many paragraph 78 disputes. Part of this process would be the timing of the jobs. This would include all elements such as parts installation, walking, sorting, etc., which then would be added together to create an average time the job could be done across all shifts that was both safe and reasonable.

This would become such a useful tool for the committee in the years to come that many of the paragraph 78 disputes would be handled in a more efficient and effective manner, making it almost impossible for management to overload jobs and putting the membership in danger. It was so useful that in 1969, when management would not honor this agreement, we would go out on strike again, but this time for a much longer period. Needless to say, at the end of this strike, management would honor "The Comparison Agreement." To this day a form of the agreement is still in place, where a formula is utilized to help resolve issues found on the job and determine the time it would take to be completed in a safe and efficient manner.

If you look at many of the tools/agreements from our past, you will see that the results can be found in your current jobs which help keep you safe and protected from many tactics management would attempt to use today.

Ben Mata was President of Local 598 from 2005 to 2011. He grew up in Flint, graduating from Flint Central High School and then, following a family tradition, hired into GM. His father was a salary worker at AC Spark Plug and his uncles were hourly workers at the Ternstedt plant on Coldwater Rd. (Local 326). He became a UAW member at Flint Truck & Bus in 1975.

Working in the Paint Shop, he was a self-proclaimed "rabble rouser," complaining often about issues in his area. He was approached by Chairman Jim Beardsley to run as Alternate Committeeman and Ben began to direct his energy by representing members in his area.

When the plant was awarded the 480 truck, Ben became part of a team that helped set up one of the first innovative agreements in a traditional GM plant. A separate line in the plant, This is the first in a series of articles about past members of Local 598.

it ran four-day/ten-hour shifts, with a "team concept" that allowed workers to have more input than standard production lines. This was during the time when GM opened NUMMI, a highly automated joint venture plant, while trying to emulate the Japanese model for manufacturing. Ben worked on problem-solving issues, reviewed new manufacturing concepts, and helped support production workers during these changes.

Ben was first elected to the Executive Board as Guide, and when former 598 President Charlie Coy was assigned to the UAW International department, VP Doug Bellamy moved up to President and Ben was elected Vice President. He then became 598's President in 2005, when former President Doug Bellamy retired. Ben was our Local 598 President until he retired in 2011.

When asked what he liked about
